### PER 220 “EMERGENCY RESPONSE TO DOMESTIC BIOLOGIC INCIDENTS”

The Minnesota Veterinary Medical Reserve Corps is pleased to host PER 220 (Emergency Response to Domestic Biologic Incidents). This two-day course is designed to help participants safely and effectively respond to a biological incident by using an integrated approach. The course provides detailed information about various biological agents and possible methods of dissemination—whether naturally occurring or intentional. Participants will identify appropriate assessment and response actions and will review personal protection, containment measures, and tools that may be accessed during a biological incident.

Professional disciplines that may benefit from this training include: Emergency Management Agency, Emergency Medical Services, Fire Service, Governmental Administrative, Healthcare and Law Enforcement, Public Health, Public Works and Veterinary Professionals.
